



Monthly Membership Contract

- A valid ID and credit card (Visa, MasterCard, AMEX or Discover) is required to enroll in a Kelly Taylor, LMT monthly membership.
- Membership contracts are **month-to-month agreements** and will auto-renew every month with your signed consent below.
- This membership entitles you to one or two prepaid sessions per month. You are also entitled to one additional service within the same month at a discount rate of 10%.
- Gift certificates purchased for anyone other than the member purchasing the gift certificate may be purchased at a discount rate of 10%.
- Appointments at Kelly Taylor, LMT are made on a first-come, first-serve basis. You are responsible for scheduling your monthly massage(s) in advance to ensure that you receive your preferred date and time.
- Unused, prepaid services **do not accrue** from month to month.
- Member benefits may be shared within an immediate family. You agree to provide family information when signing up if you intend to share your membership.
- We will use our best efforts to process all your payments promptly. However, we shall incur no liability if we are unable to completely process any of your payments because of the existence of any of the following circumstances:
 - If through no fault of ours, your payment account does not contain sufficient funds to complete the transaction or the transaction would exceed the credit limit of your credit card, or your payment account or credit card does not otherwise permit the transaction to be executed; or
 - You have not provided us with the correct account information to process your payment accurately; or
 - Circumstances beyond our control, such as but not limited to fire, flood, acts of war, terrorism or the other interference from an outside force, prevent the proper execution of the transaction and we have taken reasonable precautions to avoid the circumstances.
- Per our Cancellation Policy, please provide 24 hours notice of appointment cancellation to avoid being charged a No-Show Fee equal to 50% of total cost of your service.
- Massage membership dues do not include gratuities.
- Gift memberships may be purchased at any time.
- Monthly memberships may not be used in combination with any other promotional offers or packages, discount coupons or gift certificates.
- To cancel your membership, please provide Kelly Taylor, LMT a 30-day written notice.
- Kelly Taylor, LMT reserves the right to cancel any membership at any time.
- Kelly Taylor, LMT reserves the right to adjust membership pricing or membership services with a 30-day written notice.
